An Act amending Act No. 8365, as amended by Act No. 8411; and Act No. 8451; amending Act No. 8451, section 2(a); amending Act No. 8347, section 1, relating to the fiscal year 2021 operating budget for the Government of the Virgin Islands, to appropriate \$24,423,321 to several departments and agencies to pay outstanding obligations; and providing for other related purposes

Be it enacted by the Legislature of the Virgin Islands:

SECTION 1. Act No. 8365, section 1 is amended in the following instances:

- (a) Subsection (A), is amended as follows:
- (1) In the line item "Personnel & Fringe Benefits", strike "\$12,063,815" and insert "\$11,563,815"; and
- (2) After the line item, "Partial Payment of the settlement in Vanterpool d/b/a Vanterpool Enterprises v. Government of the Virgin Islands \$3,533,333", as added by Act No. 6451 § 1(a), insert two line items that read as follows

A payment of \$1,000 must be remitted to each service worker of the "No Virgin Islands Child Goes Hungry" feeding initiative who worked from March 1, 2020 to May 13, 2021. Payment must be remitted by December 31, 2021."

SECTION 2. Act No. 8341, section 1 is amended in the following instances:

SECTION 3. Act No. 8451, section 2, subsection (a) is amended by striking "\$638,259,749" and inserting "\$650,416,919".

SECTION 4. Act No. 8347, section 1 is amended in the following instances:

- (a) In the line item "Contribution to the General Fund", strike "\$43,219,112" and insert "\$33,219,112";
- (b) In the line item "Total Department of Finance", strike "\$43,219,112" and insert "\$33,219,112";
- (c) Insert the following two line items before "Subtotal Internal Revenue Matching Fund \$1,000,000":

"GERS OUTSTANDING EMPLOYER OBLIGATIONS \$10,000,000"

"TOTAL TRANSFER TO GERS \$10,000,000"

(d) The sums appropriated in subsection (c) constitute a payment towards the outstanding, unpaid employer contributions from 1991-2009 due pursuant to the ruling in Civil No. 1981-5 (D.V.I. Apr. 3, 2020).

SECTION 5. Act No. 8348, section 1, as amended by Act No. 8469, section 2, is amended as follows:

- (a) Strike "\$24,745,992" and insert "\$24,942,992"; and
- (b) Insert a line item that reads as follows:

"GERS Employer Contribution \$197,000".

SECTION 6. (a) Not later than 10 days after enactment of this act, the Department of Labor shall submit to the Office of Management and Budget a list of all medical providers owed outstanding vendor payments, along with the amount of the debt owed each provider.

(b) Not later than 30 days after the appropriation in Section 1(b)(5)(A) has been disbursed, the Department of Labor shall provide a report to the Legislature documenting the payments to the medical providers for Worker's Compensation services.

SECTION 7. The sum of \$400,000 is appropriated in the fiscal year ending September 30, 2021, from the St. John Capital Improvements Fund to the Virgin Islands Port Authority for the architectural and engineering design of a multipurpose use facility to support cultural events and other community purposes on the island of St. John.

SECTION 8. With the exception of the sums appropriated in Section 1, Subsection (m)(2)(b) MAP-MMIS and (m)(2)(c) MAP-Claims, affecting Act 8365, Section 1, Subsection X, all sums in this act remains available until expended.
